GENERAL REMARKS:

for Roadfreight / Seafreight / Airfreight

1.) All invoices have to show the following details:

- exact description of the goods
(stand building materials / displays / exhibition goods is not satisfactory)
- exact no. of items
- prices per unit / item
- total invoice amount (CIF Dresden)
- serial no. for all kinds of machines, devices etc.
- each item has to have a value (value „0“ will not be accepted)
- H.S. / B.T.N. Nos.
- weight per unit / item

2.) Shipment Deadlines

- FCL/ LCL seafreight port of discharge: Bremerhaven/ Hamburg: 17.09.2012
- Airfreight airport of destination: Dresden 02.10.2012
- Courier shipments which require customs clearance through us
(DHL, FedEx, TNT, UPS etc.) at Messe Dresden: 02.10.2012

**GENERAL REMARKS / Important Shipping Information for
Courier Shipments (DHL, FedEx, TNT, UPS etc.)**
